Many of us turned inward as a result of the worldwide pandemic and it forced us to delay some things as we adjusted to that new reality. Gunpowder Valley Conservancy (GVC) was no exception. This, our 2020 annual report, reflects our status at the end of that year and we hope to catch up by publishing the 2021 report by the end of this year.

We reflected on *why we do what we do* as we drafted our most recent 3 year strategic plan, new vision statement, and even our new logo. Here are just a few of our 2020 accomplishments:

**Healthy Lands**: In late 2019, we were able to place an additional 181 acres into conservation easement. Building upon this momentum, the Land Preservation committee spent 2020 focused on planning and a shift to GIS prioritization of properties that will not only help us achieve our land preservation goals, but also water quality and habitat goals.

**Healthy Waterways:** To this end, the program team successfully navigated the onset of the pandemic and met all of our restoration goals for the year. They created sound personal protection protocols to safely host environmental stewardship events that were flexible enough to meet the changing COVID-19 regulations and recommendations. We are so grateful for the efforts from staff and volunteers; organizing activities, communicating events, and getting trees and gardens in the ground.

**Healthy Communities:** 2020 saw us reaching out to our partners in the greater Baltimore community to forge new collaborations. Joining with the the <u>Greater Baltimore Wilderness Coalition</u>, we hope to expand our capacity to clean our waters while increasing our efficiency by working with like minded groups who can share the administrative load. We are looking to attract larger funding sources that target these regional coalitions.

While 2020 certainly was a strange year, your help and support helped us navigate it successfully and emerge even stronger. We are ready to push towards a watershed that we all envision for our children's future.


## **Clean Water from a Parking Lot**

In 2020, GVC received a \$75,000 Restoration and Outreach Grant from the Chesapeake Bay Trust to continue our Bay-Wise Project at Our Lady of Mount Carmel (OLMC), a Catholic parish and school situated on 8.5 acres in Essex, MD. The OLMC campus is very close to Hopkins Creek and the Chesapeake Bay. However, with multiple buildings and a large parking lot, the OLMC campus is full of impervious surfaces that generate a large volume of runoff when it rains. GVC piloted an innovative solution to reduce water pollution at OLMC-remove four parking spaces to create special gardens known as microbioretention practices (MBRs), designed with engineering features and water-loving native plants to soak up and filter the extra water. ## 2020: Year of the Reforestation Crew Chief



Thirty years ago, on a rainy Earth Day, a group of Kingsville residents, Boy Scouts, and local politicans came together to plant a single tree. It was **the first tree planted by GVC.** Many of you reading this report have helped the GVC plant more trees--over 34,000--in subsequent years. Together, we have restored over 180 acres of forested land and wildlife habitat within the Gunpowder watershed. And we did it one tree at a time.

Fast forward to 2020, GVC had hoped to have a big celebration for the 50th Anniversary of Earth Day. Instead of celebrating, GVC had to put all work events on hold in the initial months of the COVID-19 pandemic. Once we developed acceptable COVID-19 policies, we needed to play catch-up to meet our environmental stewardship goals for the year. Many of our dedicated volunteer leaders stepped up to the challenge. No longer able to accomodate 60-80 volunteers at a single tree planting event, our reforestation crew chiefs rolled up their sleeves to get trees in the ground with fewer helping hands. By November 2020, they **helped GVC plant 826 native trees across 5.5 acres**.

## Did You Know...

In 2020, GVC updated the name of its annual award to the **Charlie Conklin Volunteer of the Year** award. **Tim Somers** received the award for his 10 years of service as a Reforestation Crew Chief. He participated in 9 out of the 13 tree plantings in 2020. While most crew chiefs typically work 5 hours on tree planting days, Tim has been known to stay before or after events to do tree maintenance!

**Steve Fauser** also received the 2020 Charlie Conklin Volunteer of the Year award for his outstanding dedication as a Stream Captain. Steve, who is also a member of Baltimore County of Aging's <u>Retired and Senior Volunteer Program</u> (RSVP), and his team have removed picnic tables, washing machines, and a sofa from Beaver Dam Run in Cockeysville!

## Earth Day Anyway

Earth Day connected millions on its first observance in 1970 and is now a global effort. In early 2020, GVC had formed a robust steering committee to plan a large Earth Day event at Oregon Ridge Park. When it became clear that our original plan was no longer in the cards, we put our heads together to come up with a creative solution. The result? Earth Day Anyway!

We encouraged people to remain connected to the spirit of Earth Day, especially as we were being called to "Think Globally, Act Locally" for the sake of public health. The GVC website hosted a curated list of actions people could perform from home and/or independently in natural spaces.





## Explore the Gunpowder Watershed Challenge



As the year progressed, we saw first hand how the use of local parks had dramatically skyrocketed. Maryland Department of Natural Resources reported a <u>45 percent increase in attendance for Maryland State</u> <u>Parks in 2020 compared to the previous year</u>. What we had known for years--that the Gunpowder watershed had a wealth of beauty, history, and ecologically significant habitats--was now becoming common knowledge as more people sought out local trails for recreation, socializing and/or solace.

Simultaneously, we had to scramble to figure out an alternative fundraiser to replace our annual dinner social. Thanks to the creative vision of the GVC Events Committee we decided to launch our inaugural *Explore the Gunpowder Watershed* Challenge. Our goal was simple. We wanted to motivate people to spend time outdoors, on trails or in neighborhoods, while helping to raise \$10,000 for the GVC.



Our first annual Explore the Gunpowder Watershed Challenge was held from October 1 - October 31, 2020. We exceeded our goal and raised more than \$10,500 for our land preservation and watershed restoration work! One *Explore the Gunpowder* participant, Gregg Petersen, made several trips from Howard County to visit Loch Raven Reservoir, Oregon Ridge Park, Cromwell Valley Park, and Gunpowder Falls State Park as an *Explore the Gunpowder* participant. Gregg shared that: *"it was a pleasure to discover so many diverse and interesting places to visit...there were always some great natural discoveries to be made."* We think you'll agree when you see his bird photos!



## INCOME




## TOTAL 2020 INCOME: \$458,213
