Where We Work

The Gunpowder Watershed drains 500 square miles from York County, Pennsylvania through Maryland's Baltimore, Carroll, and Harford counties, to the shores of the Chesapeake Bay.

Our Mission

To educate and mobilize people and resources to preserve and restore the lands and waterways of the Gunpowder Watershed.



Our Vision

Our vision is a Gunpowder Watershed that consists of:

- Healthy lands where native plants and animals thrive and where natural habitats are abundant;
- Healthy waterways where streams flow clear and are connected to and nurtured by the land around them;
- Healthy communities where residents, businesses, farms, and neighborhoods thrive and are empowered with the knowledge and resources to sustain the long-term interdependency of land, water, and people.

Our Impact: Land Preservation

Land preservation is central to our vision of a Gunpowder Watershed with healthy lands, healthy waterways, and healthy communities. As of 2022, GVC held 1,867 acres in conservation easement.

Preserved land benefits us all by:

- Protecting our drinking water sources
- Sustaining wildlife habitat
- Enhancing public spaces
- Preserving our agricultural heritage

Our Impact: Watershed Restoration

- GVC has been bridging people, land preservation, and waterway restoration since 1989. In 2022, we planted 1,800+ trees, removed 7.5 tons of trash, distributed 81 rain barrels, and installed 27 conservation gardens in the Gunpowder Watershed.
- Throughout 2022, GVC offered 5 free educational workshops at Saint Demetrios Greek Orthodox Church in Parkville. The workshops were part of the Bay-Wise Project at Saint Demetrios where GVC installed 60 native trees, an Edible Bayscape Garden, and three microbioretention practices. GVC also sold rain barrels to church members to reduce stormwater runoff in their own neighborhoods.

- People came together for clean water in 2022! On June 15th, over 60 people representing 43 organizations attended the Gunpowder Watershed Forum. Hosted by GVC, this event included presentations and interactive workshops. Baltimore County Chief Sustainability Officer, Jennifer Aiosa, gave the keynote speech on Integrating Climate Change into Water Quality Efforts.
- GVC was honored to help Constellation commemorate the company's planting of more than 10,000 trees across the United States.
 Constellation employees helped plant 100 native trees at St. Francis Xavier in Cockeysville to celebrate the auspicious milestone.



2022 Financials


Cost-share reflects the homeowner's share of the cost to install rain barrels and conservation gardens thanks to GVC's generous funders.
